### **Nature of Governance:**

Dr. R. K. Shanmugam College of Arts and Science has a college governing body consisting of 7 members, college academic council with 11 members, students representatives council comprising 86 members, and college executive committee of 11 members. Their participation and collaboration in conceiving and putting decision-making plans in place for academic and administration through different groups and bodies have aided in the expansion of the college in various domains.

The governing body and Executive Counsel of the college consist of the board of directors, principal, the vice principal and the administrative officer. These bodies

provide leadership to the institution by formulating plans for development and taking crucial decisions towards the growth of the institution.

The Academic Council, which comprises of the Principal, Vice Principal and Heads of Departments, receives authority from the Executive Council and shares it with the various levels of functionaries in the institution. Academic Council has been entrusted with the responsibility of the day-to-day functioning of the college and the routine of teaching-learning activities. It also approves syllabus and curriculum for the certificate courses offered by the college. The finance committee headed by the chairman and consisting of the administrative officer approves financial grants for various purposes and ensures the optimum utilisation of the financial resources. The conveners of various committees and the heads of departments have a significant impact on the institutional policies.

### **Teachers' Participation in Decision-Making Bodies:**

In order to execute the vision and mission of the College, teachers play a crucial as well as proactive role in the decision-making process, and they strive to uphold the prominent goals of the college.

Additionally, teaching faculty participate in and lead a number of committees that are established for the regular operation of the college. The Academic Council, Admission Committee, Examination Committee and so on function well and make pertinent decisions with the active participation of teachers.
