

7.1.3 Describe the Institution's facilities for managing the following forms of degradable and non-degradable waste.

Our institute's primary operations have a very low environmental impact since they generate less trash, guaranteeing that less natural resources are consumed.

(a) Solid Waste: The waste generated by the College's everyday activities comprises paper, glass, metals, foods, and tyres, among other things. Each level and source of garbage is separated. The floor dustbins are emptied into moveable containers/dustbins provided for each block and transported to the College's disposal yard. The College has contacted an authorized vendor who collects waste from the designated location, segregates it, and disposes of it in authorized landfills.

(b) Waste Liquid:

The College generates two categories of liquid waste:

1. Waste sewage
2. Laboratory, laundry, and cafeteria waste

(c) E-Waste Management: Electronic equipment such as computers, phones, printers, fax machines, and photocopiers generate flip flops, memory chips, motherboards, compact discs, and cartridges, which are appropriately disposed. Electronic garbage generated by hardware that cannot be reused or recycled is disposed of centrally by approved vendors.





