The Memorandum of Understanding is entered into on 10th March, 2022

By and Between

DR.R.K.SHANMUGAM COLLEGE OF ARTS AND SCIENCE, represented by Er. N. GOVINDARAJU, the Secretary of DR.R.K.Shanmugam College of Arts and Science, Indili, Kallakurichi – 606 213, Tamil Nadu, herein after called as the **Party – 1**

And

The M/S. INFOINDUS TECHNOLOGIES PVT. LTD., represented by Mr. SARAVANAN MANIKANDAN, Managing Director, Infoindus Technologies Pvt. Ltd., No.79, Parvathi Nagar Main Road, Yeshwanth Nagar, Madampakkam, Chennai – 600126, Tamil Nadu, herein after called the **Party – 2**, do hereby agree the following;

- d) During maintenance process, if any additional Modules (information) requested to be updated by the Client (**Party - 1**), it will be considered by **Party - 2** (INFOINDUS TECHNOLOGIES) as chargeable service and that will be processed only after the consent of **Party - 1**.

DUTIES & RIGHTS OF THE PARTIES

- A. **Party - 1** may invite the persons / authorities of the **Party - 2** for the purpose of training of the Faculty Members of the **Party - 1**, to update the data of the institution (**Party - 1**) and maintain / handle the EDUTAG SOFTWARE of the Developer (**Party - 2**),
- B. The training may be held either in the premise of the **Party - 1** or in the premise of the **Party - 2**,
- C. **Party - 1** may utilize the available resources from the **Party - 2** to maintain the good conditions of EDUTAG SOFTWARE which is established with the institution (**Party - 1**),
- D. **Party - 2** may offer the best endless services to **Party - 1** to maintain and handle the software with at the most care,
- E. **Party - 1** may be privileged with guidance and consultancy from the **Party - 2** for the purpose of Data Updation, Service and Maintenance of the EDUTAG SOFTWARE.
- F. **Part - 2** may offer the guidance and consultancy service required by the **Party - 1** under any circumstances.
- G. **Party - 1** may be permitted to utilize the facilities of the **Party - 2** to undertake the Internship Training, Field Project, Main Project, etc., for the welfare of the students of the **Party - 1**, either in the premise of the **Party - 1** or in the premise of the **Party - 2**.

COMMON TERMS AND CONDITIONS

- A. This MOU will take effect from the date of signing by the authorities /representatives of both parties.

- b) However, the software will remain as an intellectual property of **Party – 2**,
- c) Further, **Party – 2** agrees to provide the Login credentials to **Party – 1**.

4. CONFIDENTIALITY

- a) The Developer (**Party – 2**) shall not disclose the Confidential Information / Data of Client (**Party – 1**) to any third parties,
- b) shall not make additional copies of any Confidential Information / Data or any content based on the concepts contained within the Confidential Information / Data of Client (**Party – 1**) either for personal use or for distribution of **Party – 2** to any **Third Parties**, unless **Party – 2** is requested to do so by the **Party – 1**,
- c) may use the Confidential Information / Data other than solely for the benefit of the Client (**Party – 1**) but after the proper written communication by both the parties.

5. DEVELOPER WARRANTIES

Party – 2 (INFOINDUS TECHNOLOGIES) represents and warrants to **Party – 1**

(DR.R.K.SHANMUGAM COLLEGE OF ARTS & SCIENCE) as follows;

- a) **Party – 2** gives warrantee for the established EDUTAG SOFTWARE for a period of Two Year from the time of Delivery of completed project to the **Party – 1**,
- b) After the Delivery Date, if the Software malfunctions or corrupted or in any way does not operate according to the Specifications during the time of warrantee, then the **Party – 2** shall take any reasonable & necessary steps to find & solve the issues with proper solutions and ensure the problem free functions of the Software with 0% chargeable expenses.
